Crossed cheque should be submitted to us by depositing via **HSBC cheque deposit machine** across Hong Kong. Selected locations provide 24-hour service for your convenience.

- Category for payment : Select **“Other companies”**
- Merchant for payment : Select **“Manulife MPF”**
- Bill type : Select **“01 MPF-Employer/SEP Contribution”**
- Bill account number : Enter your **7-digit Sub-scheme number** plus **2-digit Billing Class number** (if your Sub-scheme number begins with a zero, no need to enter the initial “0”).
For example:
Sub-scheme number (SSN) : 01234567
Billing Class number (BC) : 01
Please enter “123456701”

Remember to state the cheque number clearly on the Remittance Statement concerned in order to facilitate fund allocation properly. There is **NO NEED** to return the “Payment Slip” or the “Cheque Deposit Advice” to Manulife, as the Bank will automatically transmit the evidence of payment to our system.

Manulife offers different digital means to facilitate MPF contribution data reporting by employers. For maximum efficiency, please submit your contribution data online via **Contribution Express**. You may specify your payment cheque number during the submission.
